**Sub : Extension of Rate Contract in respect of the store item "PVC Plastic Pipes Schedule-40, 80 & 120 as per ASTM-D-1785/2004".**

The undersigned is to invite reference to this Directorate rate contract circulars cited above on the noted subject, and to say that the period of validity of rate contract in respect of the store item "PVC Plastic Pipes Schedule-40, 80 & 120 as per ASTM-D-1785/2004" is here by extended up to dt 18.06.2021 in favour of M/s Orison Plastic Pvt. Ltd., Plot No.F/3, 11D Centre, Khurda Industrial Estate, Dist-Khurda-752055 with effect from the date of issue of the circular at the existing rates as communicated in the aforesaid rate contract circular.

2. The details of the above rate contract indicating the name of the rate contract holding MSEs, EP&M Registration, Rate Contract No., Validity of EP&M Registration & EP&M Rate Contract for this store item, Annual Production Capacity in single shift basis, Description of the store item, rates, terms of delivery and Mode of Payment etc. have been indicated in the Statement-A, which is enclosed for your reference..

3. All other terms and conditions of the contract as communicated in the rate contract circulars referred to above will remain unaltered and will be applicable to the parallel rate contract holding SSI units.

4. The Indenting Department must ensure submission of valid EP&M registration certificate & GST (Goods & Service Tax) certificate at the time of purchase of store item.

5. The specification of PVC Plastic Pipes Schedule-40,80 & 120 as per ASTM-D-1785/2004, terms of delivery and all other terms and conditions of the rate contract as communicated earlier in the aforesaid rate contract circular will remain un-altered and also be applicable to the parallel rate contract holding SSI unit as indicated in Statement-'A'.

6. All supplies shall be on Ex-factory rates

7. As per Rules of Rate Contract 2014, Clause – 20 (V), in case the contractor fails to execute the order within the prescribed / mutually agreed time schedule liquidate damage @ 0.5% per week of the value of the quantum of materials involved in the delay subject to maximum 2.5 % shall be realized from the contractor by the indenting officer from the bill

8. Since the rate contract is a contract between the SSI units and the Govt., further agreement, security deposit or EMD may not be insisted upon.

9.. Purchasing Departments should obtained an undertaking from the rate contract holders to the effect that after execution of purchase order of the concerned Department the unit shall not exceeds its annual production capacity

10. The ultimate responsibility for ensuring quality of stores supplied be rest with the Indenting Officers. Where the Indenting Officer is not satisfied with the quality of the store items supply, he shall send a report immediately to the Director for inspection and testing by the Inspecting Officer of CIPET or jointly by the Inspecting Officer of CIPET and the Indenting Officer or his authorized agent.

11. This may please be brought to the notice of all Sub-ordinate Offices for information and necessary action at their level.

**Terms of Delivery :**


The rates for ~~fresh~~ rate contract are Ex-factory, exclusive of Goods & Service Tax(GST), which may be charged extra as admissible, if any.
